#### **RIFd Teachers**

The administrative law judge has issued her findings from the hearing, and there are 28 teachers who will receive a final lay-off notice by May 15th. 52 teachers received a preliminary notice in March, so this is definitely positive. Please keep supporting your colleagues because this is definitely an unstable and painful time for them. Any future notifications of retirements or resignations will decrease this number, so we will keep you updated.

# **PBIS TFI (Tiered Fidelity Inventory)**

The PBIS TFI will be conducted over the next few weeks. There will be PBIS Leads walking classrooms to collect baseline information, which will be used to determine the implementation of PBIS. This is not a reflection of your performance as a teacher.

A few examples of what information will be collected: positive to negative ratio, positive classroom environments, and classroom procedures. This will be the first time we are conducting the TFI, so as mentioned this will be our baseline data. #### **Contractual Issues Happening Right Now**

Remember that the contract is an agreement between CVTA and the District and it was bargained in the best interest of students and teachers. That means that both sides agreed to abide by what is included in the contract, so when something needs to be cited from the contract, it isn't what "the District said" or what "CVTA said"... it is what was agreed to and is therefore legally binding.

Find the contract here. Here are the things we are working on:

- No CVTA Grievances at this time.
- Grievances need to start at the informal level. This means that you have a conversation with your immediate supervisor, whether face to face or via email, in order to give them the opportunity to remedy the situation. It is important that you actually state, "This is my informal grievance." This will begin the timeline, and will ensure your administrator understands that there is a timeline to follow.
- <u>Williams Complaint Form</u> Some of you have asked for this form, which can be used for complaints about facilities and textbooks or instructional materials. This form could be an option when a grievance isn't the appropriate path to deal with a situation at your site
