- **Transfer Opportunities:** These will continue to be sent each Monday as new vacancies open up. Please be sure to remember contract language as it applies to transfers. You may only transfer once per year, so once you've accepted a new position for the 23/24 school year, you cannot transfer again. Additionally, if more than one person applies for the same vacancy, an interview must be held.
- **Final Evaluation Conference:** The deadline for this meeting to be held is 4/25/23. If you are asked to meet after this date, and/or asked to backdate the document, please contact your site reps immediately. It is at this meeting that you may ask to be placed on a 5 year evaluation cycle, if you qualify and if your administrator agrees.
- **CVTA Scholarships:** We are finalizing the applications and will contact the applicants soon! We had 29 applicants, and are very excited to be able to offer this opportunity to your children attending college.
