Good morning!

Tomorrow is Election Day, and the final day to submit your ballots. It is important to vote YES on Prop. 50. Find out why at cta.org/prop50 or scan the QR code above.

On Friday we met with the district to bargain/consult over some secondary SPED changes the district implemented. We were able to secure training and planning time for the affected members, as well as on-going training specific to SPED needs that will be provided during the workday, at the same time as Site PD (details on the PDs are still being discussed).

While at this meeting, we were informed by Dr. Makiewicz, co-chair of the district's bargaining team and HR Assistant Superintendent, that the CVUSD School Board and Superintendent insist that ALL bargaining sessions are held at the DO and not at the CTA Palm Desert Office as they have been for years. She stated that they are aware that it would be an Unfair Labor Practice to not allow at least half of the meetings to take place at the CTA Office, which we are willing to agree to doing. Bargaining begins on November 17, and we will meet at the DO as they've requested. As to what happens on December 5th, the second scheduled session, we do not know. We will expect it to be held at the CTA Palm Desert Office, but based on what we were told the district team will refuse to meet with us, which would mean they would not be bargaining in good faith as required. There is nothing to do but wait and see.

In the meantime, it seems this is going to be another year of contentious negotiations. Please watch for CVTA leadership to visit your site in order to make sure we are all prepared for this. We were really hoping to be able to move past all the school board and superintendent micromanaging but it is apparently increasing rather than letting up, and unfortunately it will continue to make working together difficult. The CBA states: **Article V - Negotiations Procedures -** 5.2 Meetings shall take place at mutually agreeable times and places, providing that meetings shall be held within five (5) days from receipt of a written request. **CA Ed Code 3453.5** states: It is unlawful for a public school employer to do any of the following: (c) Refuse or fail to meet and negotiate in good faith with an exclusive representative.
