CVUSD Vaccine Mandate Update ([click here to see my recent email to the school board](#))

Interactive process meetings for religious or medical exemptions are currently being scheduled and held in HR. The deadline for submitting your request if you plan to seek an exemption is Wednesday, December 15th. The latest information we have is that decisions will be sent out by the end of this week to those who attended an exemption meeting.

Decisions should be on a case by case basis and sent to the employee involved, not shared with everyone. If the district denies your exemption request, please reach out to me as soon as you can. We will need to arrange for you to be represented by a CTA attorney at the point anyone is placed on unpaid leave due to the vaccine mandate.
