I was very surprised this past week to find out how many serious situations and/or contract violations were occurring, yet CVTA had not been contacted. Things can often be taken care of if you share concerns with your site reps, who will then share with me as needed. Please don't suffer with a situation without reaching out to ask for help.

Site Budgets

Each year administrators are required (per the Collective Bargaining Agreement) to share the site budget by September 30th with the entire staff and allow for a discussion of the proposed expenditures. Most never do this, and in fact, I've only heard of two who have definitively done so this year. Please let me know if this was done at your sites during any of your staff meetings so far this year. Here is the contract language pertaining to this subject:

27.7.6 Unit members at each school site will be notified in writing of their District budget allocation no later than September 30 of each current year. Monthly printouts of expenditures will be available at each school site.

27.7.7 Site staff members will have input into proposed expenditures of budgeted funds at each location.

CVTA and CTA have made it possible for you to apply for CTA-endorsed Disability and Life Insurance with Standard Insurance Company (The Standard).

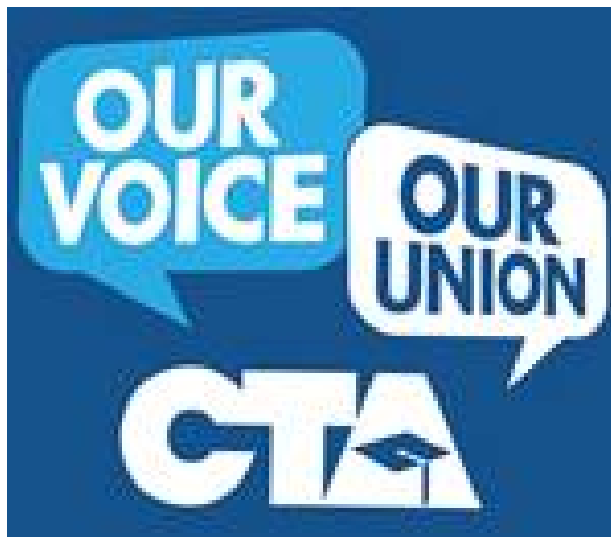
