## Greetings!

Good morning! It is hard to believe, but we have been teaching in a Distance Learning model for nearly a year. I was interviewed last week about how things are going in CVUSD and I was able to share a lot of things that have greatly improved since March of 2020. It may seem slow at times, but CVUSD has come a long way since last Spring, partly due to your amazing work.

Last week at a special board meeting, the CVUSD School Board approved Juan Lopez as our interim superintendent. Mr. Lopez has been an interim in our District before, and should be a good fit while they conduct a search for a permanent replacement.

There is a school board meeting this week on Thursday, 2/25/21. Closed session begins at 5:30 pm and open session usually begins around 6:30 pm.

## Hybrid Prep Site Visits

I continue to make site visits to see the classroom and school site set ups for teaching in person. The number one concern we have is that all safety guidelines will be followed in the Hybrid Model, so I will be looking specifically for what the School Board has been told is happening at sites in preparation. This includes the plexiglass barriers, the air filtration, the distance between students as well as students from teacher, sanitizing stations, one way path markings, etc. Each week I will give an update about what I've seen. We do recognize that it is nearly impossible to be fully set up not knowing yet which teachers will remain in Distance Learning and which will return to in-person instruction, so we are looking for sample classrooms planned at various grade levels.

- MA - Mostly planned out but not completely ready.
- VDS - Mostly planned out, but not much was ready. Some concerns about setting up the student desks.
- LP - Mostly planned and ready. Location of the isolation room was the main issue noted.
- CVHS - CVHS is planned but not finished. They haven't had all supplies delivered, and many classrooms had too much stuff, either district owned furniture or teacher personal items. Some confusion about how to set up student desks.
- BD - Totally planned and mostly ready. Just a couple of things to finish up.
- This week visiting: AE, VV, SV and OA. Still need to schedule (or reschedule) DM, WSHS, PP, ECE, and WS.

**\*It is important to restate the need for having teachers' personal items and extra furniture moved out of classrooms.** The guidance for in-person teaching states 6 feet apart for students,


but could go as close as 4 feet. Obviously 6 feet provides a safer environment than 4 feet, and if the reason they have to be 4 feet apart instead of 6 feet is because someone hasn't moved their things out, that's not okay. We have an obligation to provide a safe environment for our students just as much as we expect it for ourselves.
