CVUSD School Board Meeting

Last week the School Board held its organizational meeting and the last meeting of 2025. They elected new officers: Trustee Thomas Tortez is President, Trustee Valerie Garcia is Vice-President, and Trustee Trinidad Arredondo is Clerk. We look forward to the new leadership.

The board voted to increase their stipends by 500% (with Trustees Garcia and Vargas voting no). That is not a joke. They were receiving \$400 per month and will now receive \$2,000 per month in addition to fully paid benefits for themselves and their families. It may not seem like much on the surface, but it does amount to a 500% raise to themselves while they continue to look for cuts and decrease the services available to students.

Prior to the board meeting, the Facilities Committee Meeting was held, chaired by Trustee Jesus Gonzalez. During the meeting, Gonzalez stated that the concerns brought up about the mold and asbestos at JK and other health and safety issues were politically motivated

and dismissed them as non-issues. When we discuss concerns related to the health and safety of students and staff, it is about well-being and not about politics. It's shameful that Gonzalez continues to dismiss these concerns and other trustees on the committee sit by and do/say nothing.
