Greetings!

Good morning. We hope you had a safe, healthy, and relaxing break. Only three more weeks until Winter Break, and it will probably fly by.

As you know, the CVUSD School Board adopted a resolution at the last board meeting making the COVID-19 Vaccine a mandate. All employees are required to be fully vaccinated (14 days after the second dose of Pfizer or Moderna, or 14 days after the single Johnson & Johnson dose) in order to return to work on January 10th. **That means the deadline for the second doses, in order to be in compliance, is December 28th.** If you have already provided your proof of vaccination to HR, there is nothing more you need to do.

This is within their legal rights to mandate, and not negotiable for either CVTA or CSEA. We are able to negotiate the impact of that resolution, though, and CVTA negotiated an MOU which ensures you are able to get vaccinated within your workday (if you choose to do so) and two days of paid time off if you have side effects from the vaccine. Only two exemptions will be accepted by the district...religious or medical. Information on what is required to seek one of these exemptions was shared in an email from HR on 11/22/2021 at 10:06 am.
