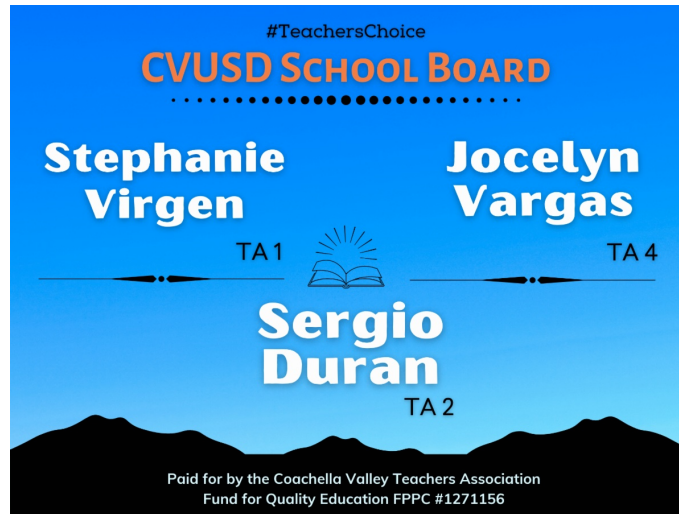

Hybrid Model MOU and Schedules

We met for the first time with the District on 9/21/2020 to go over ideas for a Hybrid Model MOU. We do not yet know when we will be allowed to offer a Hybrid Model, but there is a lot of work to be done still to prepare for in-person learning, plus we need to reach agreement on an MOU. Additionally, we'd have to be given permission by the County to reopen for in-person instruction.

We have formed small committees of classified, certificated, and admin to look over possible Hybrid Schedules, and they will begin their work this week.

We will continue to keep you updated as we did throughout the Distance Learning MOU process. Once again, if you believe you need to have a reasonable accommodations meeting with HR, contact them to get the process started. Next meeting dates are October 5th and 19th.
