**As we have shared before, there is no set target date for moving into a hybrid model at this point** , although Ed Services did propose an April 19th start date for Elementary at the March 11th School Board meeting. The board did not make a decision at that meeting and is set to discuss it again at the March 25th board meeting.

Our MOU bargaining team (Richard Razo, James Steinman, Ashley Sincosky, and CTA Staff Tomás Martínez) has worked more than 100 hours on your behalf to complete this Hybrid MOU, and we are confident that our work has resulted in an MOU that ensures the safety of all stakeholders and meets the needs of CVTA membership.
