Good morning! Online voting begins today for the CVTA Executive Board Election- check your personal email account for the link to your ballot.

- CVUSD School Board Meeting this Thursday. Closed Session begins at 5:30 pm, and the board will return for Open Session at the time shown on the agenda. The School Board Agenda will be released this evening and [can be found here](#) on the CVUSD Website.
- Preliminary RIF Notices have been delivered to far more people (110) than the School Board authorized (48). We hope to see some significant changes in the amount after the hearing being held on April 8th (and 9th if needed).
