### LCAP Meeting for CVTA Members

Last Friday afternoon, an email from the district was sent to members at each site with the information about the LCAP meeting on Tuesday. Many of you have expressed concern for how the district prioritizes its money, but very few of you have been involved in the process of setting those priorities. This is your chance to get involved!

There will be three Zoom meetings just for CVTA members this year, each meeting with a different focus. Please plan to attend each one to learn about what money the district gets, where it has been prioritized, and most importantly to share your ideas about what should be prioritized in future budgets. It's on Zoom, and won't take too much of your time for such an important chance to effect spending priorities in CVUSD!

### CVUSD Vaccine Mandate

Interactive process meetings for religious or medical exemptions are currently being scheduled and held in HR. Please don't wait too long to submit your request if you plan to seek an exemption. As of this morning, we are not aware of any approval/denial decisions made by the district for those meetings already held.

We anticipate that decisions from the district will be made sometime this week (decisions should be on a case by case basis and sent to the employee involved, not shared with everyone). If the district denies your exemption request, please reach out to me as soon as you can. We will need to arrange for you to be represent by a CTA attorney at the point anyone is placed on unpaid leave because of the vaccine mandate.

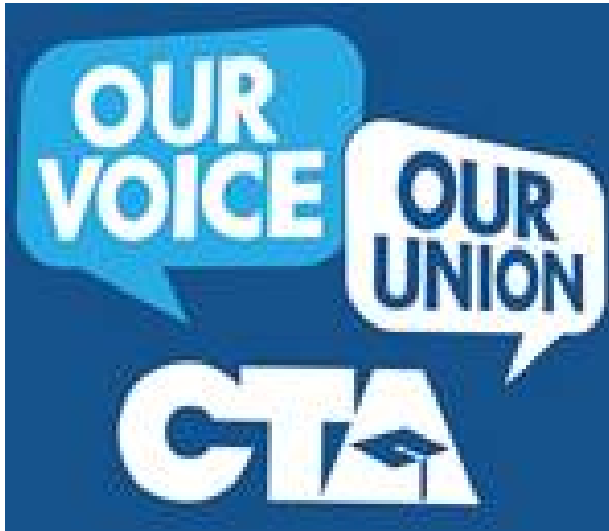
