### Greetings!

Good morning and welcome back from break! Hopefully you enjoyed some relaxing time off.

As you know, today is the deadline to be fully vaccinated or to have an approved exemption. I believe there are very few certificated staff who did not do either option...please contact me if you are one of them.

We know that positive cases are increasing daily, as this new variant is highly contagious. Please follow all safety precautions, speak up if you see others who are not, and notify your admin and/or site reps if you have concerns. It is not an option at this time to do any sort of remote learning because the state has not authorized it as they did in 2020/2021. Large site meetings should be held virtually...please ask your site reps to contact us if large meetings are held in person.

The requirement that schools have procedures enforcing mask requirements has not changed: districts *must* have protocols for providing a face covering to any student who inadvertently fails to bring one to school. Procedures for enforcing mask requirements should include independent study for students who refuse to wear masks ([CDPH K-12 Guidance, updated 11/24/21, Safety Measures 1e](#)).

Please remember that if you contract COVID while at work or have to quarantine because of exposure at work, we recommend filing for workers compensation. The District is obligated to continue paying you if it is work related, and *they* must prove that it was not contracted at work. Anyone excluded from work due to a positive COVID-19 test continues to be entitled to exclusion pay under the Cal/OSHA ETS ([Section 3205\(c\)\(9\)\(D\)](#)), as those Standards were recently extended from January 14 through April 14, 2022.
