Good morning. We have another great week ahead of us, and a three-day weekend coming up!

Here are a few important items to share this week:

- August Paycheck: This month's check will not have deductions (such as membership dues), and therefore will be slightly greater than the other 10 you will receive.
- Catastrophic Sick Leave Bank: You may enroll in this bank during the month of September only (with the exception of newly hired employees during the school year). For those already enrolled, they will take one day from each person this year. Complete the enrollment form in School Stream if you would like to join the bank.
- Subbing on your prep (secondary): Please know it is completely voluntary to cover a class during your prep. You do have the right to say no if asked, and should not be made to feel bad for doing so. Please speak to your reps if this is happening.
